- **Communications**—Bruce was absent but did share via e-mail that website has been updated.
- **Modernization**—Peggy will handle e-blasts. Andre' asked if we have sub email. We will address at next meeting.
- **Social Events**—Peggy is chairperson for this committee. She will handle organizing Halloween party which will be addressed at next meeting.
