against the property of the corporation; (c) acquire by gift, purchase or otherwise own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the corporation; (d) borrow money and with the assent of two-thirds of the members of the board of directors, mortgage, pledge, deed and trust or hypothecate any and all of its real or personal property as security for money borrowed or debts incurred; (e) have and to exercise any and all powers, rights, and privileges which the corporation organized under the Non-Profit Corporation Law of the State of Michigan by law may now or hereafter have or exercise.

### ARTICLE VII - CONCLUDED-

- A. Membership. Every person or entity who is a record owner of a fee or undivided fee interest in any lot which is subject by covenants of record to assessment by the corporation in accordance with the declaration including contract sellers shall be a member of the corporation. The foregoing is not intended to include persons or entities who hold an interest merely as security for the performance of an obligation. Membership shall be appurtenant to and may not be separated from ownership of any lot which is subject to assessment by the corporation.
- B. Voting rights. The corporation shall have two classes of voting membership. Class A.—Class A members shall be all owners with the exception of E.V.A. Associates or its successors. Class A members shall not be entitled to vote until such time as 80% or more of the lots in said subdivision have been sold by E.V.A. Associates or its successors and assigns. Class B the Class B members shall be E.V.A. Associates or its successors and assigns and shall be entitled to appoint the board of directors of this corporation until such time as 80% of the lots in the said subdivision have been sold. Thereafter Class B membership shall cease.
- C. Board of Directors. The affairs of this corporation shall be managed by a board of not less than three members nor more than fifteen members who shall be members of the corporation.

# Articles of Incorporation—Non-Profit Corporations (Excluding Ecclesiastical Corporations)

- Article II should state, in general terms, the specific purpose or object for which the corporation is organized.
- Article V—At least three incorporators are required. Article VI—At least three directors (or trustees)
  are required. The addresses should include a street number and name (or other designation), in
  addition to the name of the city and state.
- 3. The duration of the corporation should be stated in the Articles only if the duration is not perpetual.
- The Articles must be signed in ink by each incorporator. The names of the incorporators as set out in Article V should correspond with the signatures.
- An affective date, not later than 90 days subsequent to the date of filling, may be stated in the Articles of Incorporation.
- One original copy of the Articles is required. A true copy will be prepared by the Corporation and Securities Bureau and returned to the person submitting the Articles for filling.
